What to bring to a FREE Tax Prep Site:

- ✓ Photo Identification
- ✓ Social Security card or ITIN card for each family member
- ✓ W-2, W-2G, and 1099-R forms for all jobs worked in 2010
- ✓ Unemployment Compensation, form 1099-G
- ✓ Child care provider name, address, and tax ID number
- ✓ A copy of last years state and federal tax returns (if available)
- ✓ All other tax related documents
- ✓ All banking account information (including a voided check or savings deposit slip) to directly deposit your refund
- ✓ If you are married filing jointly, both spouses must come to sign the return
